





Admission Process

Eligibility

A candidate who is a graduate from any discipline from a recognized university with a minimum of 50% aggregate marks. A candidate appearing for final year may also apply.

Entrance exam scores accepted: CAT, XAT, CMAT, GMAT, MAT, ATMA, MHCET (for Pune campus), K PGCET (for Harihar campus).

Evaluation Parameters

Candidates are evaluated and shortlisted on the basis of overall rank computed, taking into account the following components described by AICTE:
